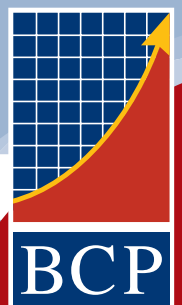

This innovative bond offers investors a two tier investment package. 25% is placed in a 12 month fixed high yield deposit account which assures investors of a 5% gross gain (5% AER). 75% is invested in a 5 year 3 month capital secure Absolute Return Bond.

HOW THE BOND WORKS

12 MONTH HIGH YIELD DEPOSIT ACCOUNT

25% of the BCP Split Deposit Absolute Return Bond 8 is placed in a 12 month deposit account (the "High Yield Deposit Account") which assures investors of 100% capital security provided by Investec, and assures investors of a 5% gross gain (5% AER) on the deposit element.

At the end of 12 months, on 2nd April 2015, 25% of the investment amount along with deposit interest of 5% gross (5% AER) will be paid out to investors. Where applicable, interest will be paid after deduction of Deposit Interest Retention Tax (DIRT) currently 41%.

ABSOLUTE RETURN BOND

The Bond will pay investors 80% of the Performance in the **Carmignac Patrimoine Fund** ("the Fund") over the 5 year 3 month investment Term. **There is no limit to the maximum return that can be earned from the Bond.**

ABSOLUTE RETURN BOND - INVESTMENT RATIONALE

The **BCP Absolute Return Bond** is an investment that aims to produce consistently positive returns, regardless of the investment environment. The **BCP Absolute Return Bond** provides access to an investment that was traditionally limited to only the largest of investors. 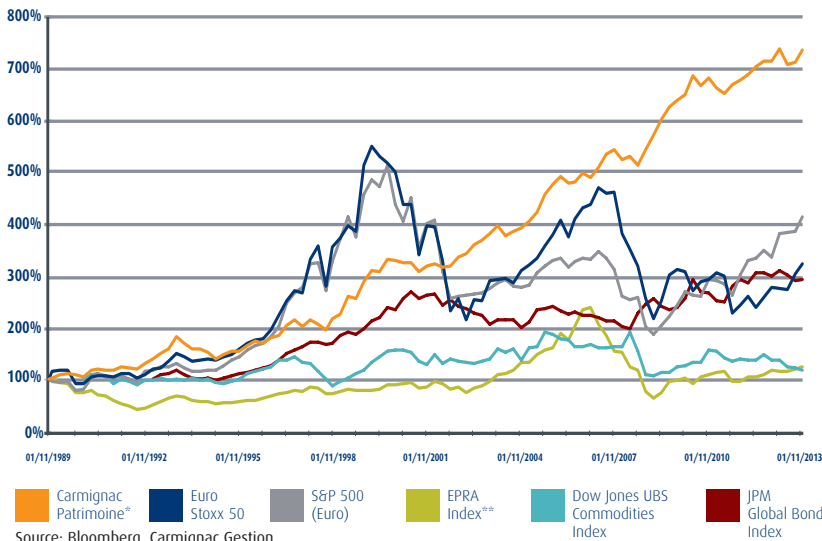

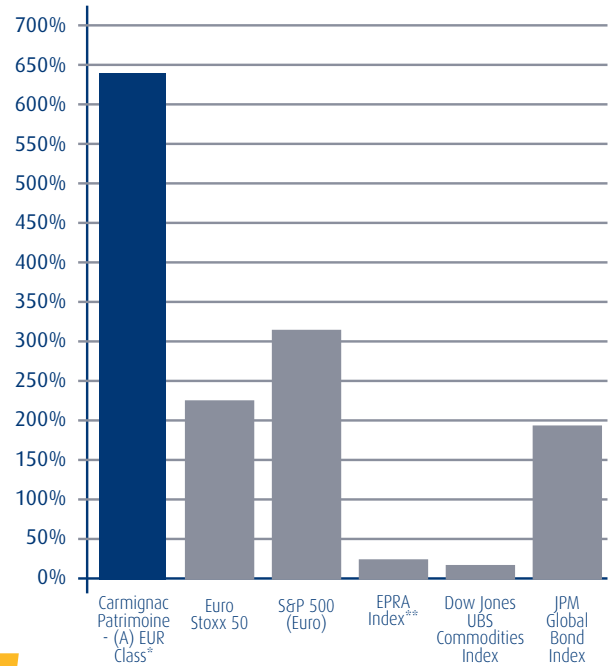
PAST PERFORMANCE OF CARMIGNAC PATRIMOINE FUND

ABSOLUTE RETURN BOND

▲ CALCULATION OF RETURN

Whatever the Performance achieved by the Carmignac Patrimoine Fund over the investment term, the Bond will pay 80% of this growth. There is no limit to the maximum return that can be earned from this Bond. Investec provides 100% capital security so even if the Performance is negative over the term of the Bond, Investec will pay 100% of the investment amount at the end of the term.

▲ EXAMPLE RETURN

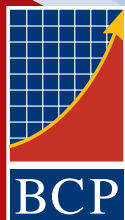

Please note this applies to Existing as well as New Clients. Additional documentation will be required for Corporate, Pension and Charitable organisation applicants.

3. YOUR INVESTMENT

- 3.1 BCP will lodge your investment into a client asset account at the Bank in the name of BCP. On or before the commencement date the funds will be transferred into an account in your name with the Bank. You will receive a confirmation from the Bank of your investment in the Bond. The Bank's general Terms & Conditions apply to all accounts, and are available at www.investec.ie or upon request from the Bank or BCP. Client asset accounts contain funds which are pooled with other clients' funds. Investors have a claim against the client assets pool in a specific account. Funds are not afforded protection under the Client Asset Account Requirements until they are swept from the clearing account at the Bank into the BCP Client Asset Account.
- 3.2 At the end of the 12 month Term, the capital placed in the High Yield Deposit Account together with 5% gross interest (5% AER) will be returned less DIRT if applicable. At the end of the 5 year 3 month Term, on advice from BCP, the Bank will pay the capital secure amount in the Absolute Return Bond/90 Absolute Return Bond 4/120 Absolute Return Bond 2, together with any Interest earned.
- 3.3 Your money is not invested in the Fund, therefore, the investment does not benefit from any dividends paid by the Fund. Carmignac Patrimoine is a diversified fund that uses three performance drivers: international bonds, international equities and currencies. This provides multiple layers of diversification and potential returns. As well as capital appreciation on the assets held, any dividends received from equities, coupons received from bonds or interest from cash deposits are all included in the investment return for investors.

4. AVAILABILITY

- 4.1 The closing date for applications is 21st March 2014, or earlier if fully subscribed (the 'Closing Date').
- 4.2 The minimum investment is €20,000.
- 4.3 The Bond is available to individuals who are aged 18 or over investing on their own behalf, credit unions, charitable bodies, companies and pension funds. Individuals under 18 may be facilitated by way of a flexible trust.

5. COOLING OFF PERIOD

You have the right to cancel this contract prior to the Closing Date of the Bond. If you wish to cancel, written notice must be received by BCP Asset Management Limited at 71 Upper Leeson Street, Dublin 4 within two weeks of your application but no later than 21st March 2014.

6. WITHDRAWALS

- 6.1 No withdrawals may be made from the Bond before the end of the 12 month Term and 5 year 3 month Term.

- 6.2 In the event of death of a sole investor prior to the expiry of the terms: (a) the Bond may be transferred into the names of the deceased investor's personal representatives or of any other person nominated by such personal representatives, or (b) the Bond may be redeemed, subject to normal probate regulations, at its realisable value as determined by BCP and the Bank, which may be more or less than the remaining capital secure amount.
- 6.3 Where the Bond is held in joint names, it will, upon the death of one of the investors and upon production of such evidence of death as BCP or the Bank require, be transferred into the name(s) of the surviving investor(s).
- 6.4 Where an investment is made on behalf of a self directed or self administered pension plan, in the event of death of a member prior to the expiry of the 5 year 3 month Term, the Bond may be redeemed, subject to the terms of the rules of the underlying scheme or policy, at its realisable value as determined by BCP and the Bank which may be more or less than the remaining capital secure amount. 7. INTEREST

- 7.1 The Interest payable on the 12 month High Yield Deposit Account at maturity will be 5% gross (5% AER). This deposit will mature on 2nd April 2015. The interest payable on the 5 year 3 month deposit on maturity is based on the Performance of the Fund from 2nd April 2014 to 2nd July 2019. In respect of the Absolute Return Bond, the interest will be 80% of the positive Performance achieved. In respect of the 90 Absolute Return Bond 4 the Interest will be 90% of the positive Performance achieved. In respect of the 120 Absolute Return Bond 2 the Interest will be 120% of the positive Performance achieved. This Interest, if positive, will be added to the capital secure amount in each Bond to calculate the return.
- 7.2 If the Performance of the Fund is negative, at maturity you will receive 100% of the amount invested in the Absolute Return Bond/90 Absolute Return Bond 4 and 95% of the capital invested in the 120 Absolute Return Bond 2.

On suspension, the Bank shall arrange for the investment accrued to be placed on deposit for the aforesaid period, on terms to be agreed between BCP and the Bank at their absolute discretion. BCP will notify the investors of the occurrence of any such event in such manner as BCP deem appropriate. - 7.5 Should an adjustment event occur during the 5 year 3 month Term which affects the Fund or the value of any unit of the Fund including, without limitation: a split, consolidation or reclassification of the units, or a distribution in the form of dividends which does not comply with the usual dividend policy of the Fund, or any other similar event which in the opinion of BCP requires an adjustment, BCP shall be entitled, after consultation with the Bank and at its absolute discretion, to adjust any relevant terms of the Bond to preserve the economic equivalent of your investment prior to the occurrence of such adjustment event.
- 7.6 Interest will be paid after deduction of Deposit Interest Retention Tax ('DIRT') where applicable. DIRT to be deducted will be calculated in accordance with the appropriate tax legislation and at the rate prevailing on maturity, currently 41%. Certain investors may apply to have interest paid without deduction of DIRT. All necessary DIRT exemption documentation is required to be in place prior to interest payments.
- 7.7 Unless by special arrangement for sums in excess of €100,000, no interest will be paid to you in relation to the period up to 2nd April 2014.

8. MATURITY

BCP will contact you before the Bond matures to advise of repayment and reinvestment opportunities available at that time. At maturity on 2nd April 2015 and 2nd July 2019, BCP will, following receipt of your instructions, instruct the Bank to issue and send individual customer cheques to BCP amounting to the remaining capital sum secured together with any Interest earned OR reinvest the proceeds as instructed. If for any reason Interest on the Bond cannot be determined

by the maturity date, the Bank will pay the remaining capital sum secured and any Interest, 2 business days after the Interest can be determined. In the event no instruction is received by maturity, your investment will mature with the funds remaining in a non-interest bearing account with the Bank.

9. JOINT ACCOUNTS

Unless otherwise agreed in writing with BCP, the withdrawal of funds at maturity will require the consent of all account holders. 10. COMPLAINTS

Any complaint about the sale of this Bond should be made to your authorised intermediary via whom you invested in the Bond. A complaint about any other aspect of this Bond should be made to BCP. Any such complaints will be investigated in accordance with BCP's complaints policy, details of which are available from BCP.

11. CONFIDENTIALITY

BCP and the Bank observe a strict duty of confidentiality about your financial affairs. Save at your request or with your consent, neither BCP nor the Bank will disclose any details relating to your investment to anyone else other than in the following circumstances:

- to comply with a Court Order.
- to comply with a direction or request from a statutory or regulatory body entitled to such details.
- in accordance with any applicable legislation.

12. DATA PROTECTION

Both BCP and the Bank are registered under the Data Protection Acts 1988 and 2003 and your personal data held by BCP and the Bank will be maintained in accordance with the obligations of the Acts and subsequent legislation.

13. CANCELLATION

If total funds received from investors at the Closing Date are deemed to be insufficient, BCP reserves the right not to proceed with the Bond issue and to repay investors.

14. ASSIGNMENTS

Investor(s) may not transfer (either by assignment or by novation) or create any security over any or all its rights, interests and obligations in the Bond without the prior written consent of BCP.

15. BOND OPERATION

Neither BCP, the Bank nor their agent(s) will be liable for any loss you may suffer if BCP, the Bank or their agent(s) is prevented from providing any service as a result of industrial action, power failure or other cause beyond the reasonable control of BCP, the Bank or their agent(s). 16. VARIATION

These Terms and Conditions may be changed if a decision, recommendation or change is made by a Court, Regulator, Ombudsman or by legislation. BCP will notify you personally of any changes and will endeavour to give you at least 1 month's notice.

17. INVESTOR DEPOSIT ACCOUNTS

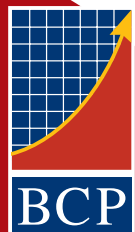
